Organizational Background: Proyecto Pastoral was founded in 1986 to empower the Boyle Heights community through grassroots projects in education, leadership, and service. Proyecto is a highly effective community-based organization that focuses on building residents' leadership to create change in their community. Our initiatives include: Guadalupe Homeless Project, an emergency shelter and clothing distribution center for recently immigrated men and senior-aged women; IMPACTO, a multi-faceted youth development program; Early Childhood Education Centers, focused on preparing children 18 months to 5 years old for Kindergarten; and Comunidad en Movimiento, focused on civic engagement and leadership development. Proyecto Pastoral is the backbone organization for Promesa Boyle Heights, a cradle-to-college/career initiative. Proyecto Pastoral serves nearly 8,000 children, youth, and families.

Position Description:

The Temporary Recreation Assistant will be responsible for ensuring the safety and support of Food Distribution & indoor / outdoor recreation activities at the Aliso Pico recreation center to best service all scheduled programming. The Temporary Recreation Assistant reports to the Aliso Pico Recreation Coordinator and works alongside the center staff to ensure the site is available to provide high quality programming.

KEY RESPONSIBILITIES:

Distribution:

- Support distribution of in kind donations, may include unloading, sorting, packing, redistributing goods at the Recreation Center site.
- Open and close the facility properly, walk grounds to maintain the safety of all accessing space.
- Liaison between Recreation Coordinator, After School Program Coordinator and Community Residents to support services.
- Identify and report possible repairs.
- Clean buildings by emptying trash, sweeping, and cleaning surfaces.
- Clean outdoor area assuring the space is free of glass, bulky trash and dangerous hazards.
- Monitor building security and safety by performing such tasks as locking doors before or after operating hours and assuring hazards are not created or materials are not left unattended.
- Liaison between Recreation Coordinator, Site Supervisor and Community Parents to better direct families interested in recreation enrollment.
- Assist in phone banking clients to inform them of upcoming services.
- Clean and disinfect student recreation equipment.
- Compile and Input weekly Attendance counts in tracking system.

Recreation:

- Work as part of the team to offer high quality recreation development and community programming.

- Support Indoor and Outdoor recreational activities by setting up/down for practices, communicating with instructors/coaches/referees and families.
- Liaison between Recreation Coordinator, After School Program Coordinator and Community Parents to assist in program enrollment and information.
- Support with community flyer to outreach and support recreation activities.
- Supervise and monitor Recreation activities during games and practices.
- Support in quarterly indoor sports registration.
- Maintain quarterly recreation attendance reports.
- Clean and disinfect student recreation equipment.
